


Performance vs Benchmark





Performance – 31st August 2025





@ 1860/-

- Dominant player in the Indian airline industry with 60% market share.
- Only other competitor is Air India, which is currently in transition.
- Huge demand tailwind from the growth of air travel, airport expansion and pent-up demand post covid.

Competitive Advantage

- Lowest cost structure and Widest network
- Exclusive airline sourcing strategy with airbus improves maintenance efficiency and cost reduction
- On time performance associated with the brand

Valuation

- Revenue of 56,000 crore with an ex-covid PAT margin of 9%. Normalized net profit is 5,000 crore.
